EACH PRIZE IS CONFERRED BY A PANEL OF PEN MEMBERS WHO BRING TO THE TASK A FAMILIARITY WITH THE SOLITARY TASK OF CREATING GREAT LITERATURE. IN JULY 2011, OUR TRANSLATION FUND GRANTS WERE PRESENTED TO 11 TRANSLATORS TO SUPPORT THE TRANSLATION OF BOOK-LENGTH WORKS.
